Our agency has received the attached request. Please accept this email as a response to the information requested.

1. When a shelter in Hardee County is opened, sexual offenders and predators who choose to seek shelter may do so at Hilltop Elementary School, which is one of the first shelters to open in Hardee County. If an offender/predator is in need of special (medical) accommodations, they can preregister with Hardee County Emergency Operations Center for a space in the special needs shelter, which is at South Florida State College.

Hilltop Elementary School - 2401 US Highway 17 North Wauchula, FL 33873 South Florida State College - 2968 US Highway 17 North Bowling Green, FL 33834

2. Those offenders who are registered offenders/predators and are residents of Hardee County are welcome to go to the shelter as soon as it is open. Everyone entering the shelter must register upon arrival at the shelter. Offenders/Predators must make contact with the Hardee County Sheriff's Office deputy on duty at the shelter where they will be directed to an area separate from the general population.

3. Hilltop Elementary School - 2401 US Highway 17 North Wauchula, FL 33873

South Florida State College - 2968 US Highway 17 North Bowling Green, FL 33834

4. Only offenders/predators will be allowed in the designated area. Other family members must remain in the general population area.

5. If the offenders/predators remain at the shelter for 3 or more days, accommodations will be made for them to comply with registration requirements.
