2014 REGISTRATION UPDATES

TO: All persons required to register in Florida as Sexual Offenders or Sexual Predators

FROM: The Florida Department of Law Enforcement, Florida Sexual Offender/Predator Registry

EFFECTIVE DATE: OCTOBER 1, 2014

This is a courtesy update regarding several changes to Florida's registration laws for sexual offenders and predators which are effective October 1, 2014.

Please Note: This notification highlights some of the registration requirements that are new or updated and does not include all of the requirements listed under F.S. 943.0435 and F.S. 775.21. REGISTRATION AS A SEXUAL OFFENDER OR PREDATOR IN FLORIDA NOW INCLUDES THE FOLLOWING:

*Voluntarily using personal information such as your date of birth, social security number, or PIN (personal identification number) as an Internet identifier waives the disclosure exemption for that information.

REGISTRATION REQUIREMENTS

REQUIRED REGISTRATION INFORMATION CONTINUED:

- Tattoos & Other Identifying Marks
- Palm Prints
- Passport, if you have a passport
- Information/Documents establishing your immigration status, if you are an alien
- Professional Licenses

CHANGES TO REGISTRATION REPORTING:

You are required to report <u>in person</u> to the sheriff's office WITHIN 48 HOURS after <u>any change</u> in "vehicles owned" (see page 1) to report those vehicle information changes. {F.S. 943.0435(2)(b)3; 775.21(6)(a)1.c}

CONTACT YOUR SHERIFF'S OFFICE** NOW
TO MAKE ARRANGEMENTS TO UPDATE YOUR VEHICLE INFORMATION AS REQUIRED.

- In addition to regular biannual or quarterly registration, if you have a registered "transient residence" you must report to the sheriff's office
 - o WITHIN 48 HOURS AFTER ESTABLISHING A TRANSIENT RESIDENCE in that county AND
 - IN PERSON <u>EVERY 30 DAYS</u> TO THE SHERIFF'S OFFICE to report addresses and locations while you are transient.
 - Failure to report every 30 days as required is a 3rd degree felony. {F.S. 943.0435(4)(b)2;
 775.21(6)(g)2.b}

Each sheriff's office will establish procedures for reporting transient information. "Transient residence" means <u>a county</u> where you live, remain, or are located for a period of **5 or more days in the aggregate during a calendar year** and which is not your permanent or temporary address. The term includes, but is not limited to, a place where you sleep or seek shelter and a location that has no specific street address.


- Those who intend to establish a permanent, temporary, or transient residence other than in the State of Florida, must report in person to the Sheriff's Office in the county of current residence within 48 hours before the intended date of leaving Florida, or within 21 days before the planned departure date if the intended residence of 5 days or more is outside of the United States. {F.S. 943.0435(7); 775.21(6)(i)}
- If you are unable to secure or update a driver license or identification card with the Department of Highway Safety and Motor Vehicles as required, you shall <u>also</u> report any change of residence or change in name by reason of marriage or other legal process within 48 hours after the change to the sheriff's office in the county where you reside or are located and provide confirmation that you have reported that information to the Department of Highway Safety and Motor Vehicles. {F.S. 943.0435(4)(a); 775.21(6)(g)1}

IT IS A 3RD DEGREE FELONY TO KNOWINGLY PROVIDE FALSE REGISTRATION INFORMATION BY ACT OR OMISSION. {F.S. 943.0435(14)(c)4; F.S. 775.21(10)(a)}

Use of the Cyber Communication System for registering Internet Identifiers

As part of the new requirements for sexual offenders and predators in Florida, subjects are required to register all "Internet Identifiers" prior to use. Registrants should submit this information either by visiting their local sheriff's office to complete an information update or through the online Cyber Communication System (CCS).

In CCS, registrants currently have the option to submit either an email address or Instant Messenger (IM) name. Registrants should enter all **non-email "Internet Identifiers" via the instant messenger (IM) name option as outlined below**. The CCS site can be reached through a link on the FDLE Sexual Offender/Predator website or at https://offender.fdle.state.fl.us/ccs/displayLanguagePref.a



Once logged into CCS, registrants should select the "IM" radial button and then enter their "Internet Identifier" under *Account Name*. The provider is then selected from the available list or, if not listed, can be entered as "Other" by using the "*Other Provider*" box.

Registrants should then click the "Add Account" button. Before exiting CCS, each registrant should carefully check to ensure all information in the system is complete and accurate.
