





# The Child Scarlet Letter: Why Juvenile Sex Offender Registration Laws are Unconstitutional and the Lessons they Offer on Adult Registration



Catherine Carpenter Los Angeles, California As we push to change inherently unfair and deeply flawed adult registration laws, it is important to turn our attention to children who are forced to register as sex offenders, often for the remainder of their lives. By some accounts, children represent 25% of state registries. Not only is their registration an injustice that deserves greater national attention but also proving that juvenile registration is unconstitutional helps inform our fight against adult registration.

# How Metaphors Kill: The Dehumanization of Sex Offenders





Moral panic over sex offending implicates the media, politicians, police, courts, and others in what has been called a "hot" approach to sex offense recidivism. "Hot" approaches lend themselves to unconstitutional legal procedures, such as Megan's and civil commitment laws. But if sex offense recidivism were to be construed as a public health problem, very different strategies become available, "cold" strategies that can both effectively protect society and protect the rights and human dignity of sex offenders. This talk is a step toward a humane approach to recidivism, by suggesting a public health model of prevention rather than a preventive state as a corollary of the criminal justice system. The public tends to view sex offenders as monsters, and the law reflects that dehumanizing metaphor. The monster metaphor points in the direction of Draconian recidivism prevention strategies, such as registration and civil preventive commitment laws. state. however. constitutionally infirm. A far more reliable and Constitutional approach to recidivism is to utilize public health strategies that seek to protect society while also protecting the rights of sex offenders.

Craig will discuss how his book THE DOLPHIN came to be written, detailing his discovery of the injustice of registration, including witnessing the difficulties of a registrant friend. He will provide insight as to how/why registration came about. Craig's parents were both journalists and defenders of civil rights. He and his children continued the tradition by advocating for members of the LGBTAQ community for many years. When he learned of the injustice of sex offender registration and the hysteria and lies on which it's based, he knew he had to speak out. It's in his DNA.

Welcome to this year's RSOL conference from all of us in Maryland. Here's hoping that you learn, enjoy, and leave ready for action!






# Media Presence

Journalists and other media will be at this year's event. We are also streaming online for those who were unable to attend. However, the comfort and security of our guests is paramount! Media are only permitted to question attendees after clearance is granted by RSOL staff AND the person they wish to question.

Media are required to shoot from the back of a room to avoid capturing faces. As an additional safeguard, though, you selected a particular colored lanyard at check-in that will indicate whether you are comfortable being caught on film. This badge alerts media that if they see a red "do not film" lanyard in any footage or photos, that person's face should be fogged.

## Constitutional Registry Challenge in Florida



Gilbert A. Schaffnit Gainesville, Florida

Mr. Schaffnit will be speaking about a challenge he will soon be filing against the Florida sex offender registry based on both the Florida and US Constitutional provisions. Florida has substantial compliance with the AWA - lifetime registration with no ability to petition the Circuit Court for removal for 25 calendar years after complete release from supervision. His challenge will be based on the 5th and 14th Amendments' lack of rational basis for the 25-year provision, as well as lack of due process and ability to access the Courts for redress of grievances, denial of equal protection, and cruel and unusual punishment. He will be arguing that, a la Padilla v. Kentucky, lifetime registration is not a mere collateral consequence of conviction (as deportation was before Padilla) but permanent and unconstitutional a punishment after a sentence is served which, unlike civil commitment, is not based on a present and continuing threat to the community. No threat equals no need to notify the community.

## One Person Can Make a Difference



One person has often made the difference in changing the views and the actions of a nation. For example, Mahatma Gandhi led a peaceful revolution that ended British rule in India, and Nelson Mandela led a similar movement that stopped apartheid in South Africa. Ms. Bellucci will explore how these individuals and others did what many thought was impossible and how you can apply those qualities to your life.

## Five Arguments for Sex Registries—and Why They're Wrong



Steven Yoder Woodstock, New York

Those who advocate the abolition of sex offender registries, residency restrictions, Halloween ordinances, and other laws run up against a range of objections--from politicians, opposition advocates, reporters, and even friends and acquaintances. The most common counter-arguments are based on faulty or misleading data, misconceptions about the goals of reform, or flawed logic. A strong performance in debates and discussions-whether online, in-person, or in testimony-matters in changing public policy. Answering the objections is critical to convincing the public and decision makers of the need for change. We will tackle the most common counter-arguments to reform head on. How do you respond when someone points out that sex crimes are underreported--and thus that low registrant recidivism rates can't be proven? How about when someone says registries are justified because the offender chose to perpetrate a crime against an innocent child? And aren't these laws justified if they protect even one young person? You will leave armed with a set of talking points for responding in these exchanges.



### Guidelines in Child Pornography & Enticement Cases By Gilbert A Schaffnit

The presentation will discuss the congressional development child of federal sentencing guidelines, including a brief discussion of the types of sentences imposed prior to the advent of the guidelines. ### Rarely Well Done: How to Build More & Positive Media Content

#### By John Sarna and Jean Kennedy

A positive media presence is vital to effectively pornography/enticement dealing with public perceptions about sexual offenders and increasing support for real reforms. Accurate information from reliable media sources will aware and supportive of our reforms. Our advocacy and goals are advanced through personal stories; discussions with experts from legal, medical, and other fields; and building alliances with other groups that advocate reforms for safer communities rooted in common sense, proven research, and best practices. Mainstream media often follows agendas that are counter-productive, even inimical to registrants and to meaningful reforms. More programs similar to "It Could Be You" will educate more people and build support for advocacy goals.

## Statutory Rape & Strict Liability By Catherine Carpenter and Larry Neely

Professor Catherine Carpenter and Larry will explain the challenges we face due to the proliferation of strict liability offense schemes, particularly for consensual sex with minors and internet solicitation. Legislatures have routinely eliminated Mens Rea despite the fact that the Supreme Court has held that criminal liability is normally based upon the concurrence of two factors: "an evil-meaning mind and an evil-doing hand." The workshop will examine potential legal challenges to strict liability statutes.

# Stigma and Status: Researchers & Scholars in the Sex Offender

A wealth of research exists that shows registries are will help families be prepared to help their registered ineffective and serve primarily to shame. However, those on the registry and their family members face special challenges, specifically because of this shaming, when it comes to highlighting the injustice of these policies. Registrants are also fearful because of the vulnerability they face due to their permanent exposure on the public registry, and speaking up can housing, employment, and consequences. Thus, researchers and scholars must take the lead role in reform efforts. Those on the registry are subject to marginalization and stigma, unlike any other subset of criminal offenders, and require outspoken and forceful support from researchers and critics of these policies.

We've been following his story for the past couple of years and look forward to joining him.

The more we understand, that better we feel we can address questions in our film. Second, we look forward to shooting with our main character and others connected to our film during the conference. In addition, we are still "casting" our film, and

invite anyone with the profile we are working with to talk to us. Note that we are primarily interested in working with young men who were charged with CP possession when they were between the ages of 18 - 24.




#### John Douard, Defense Attorney, New Jersey

#### Andrew Stein, IT Consultant


