Course: JUST 402 - Sex Crimes Offered at Montclair State University, Department of Justice Studies by Lisa Anne Zilney, Ph.D.

COURSE DESCRIPTION

The primary goals of this course are to cultivate a criminological, psychological, and legal understanding of sex crimes and sexual offending. We begin with an examination of the history of sexual offending and a look at the theoretical explanations. We spend a considerable amount of time discussing high profile sexual offense cases and the impact of these cases on the creation of a moral panic and a multitude of "get tough" responses by the legislature. We also discuss "so-called" sexual offenses such as public sex, sodomy, swinging, etc. We examine how sexual offenders are controlled in society: As we examine legal controls such as Megan's Law and Sexually Violent Predator legislation, this will involve an investigation into the dilemma of balancing the rights of the offenders and the rights of the community, and what types of community protection are available for sex offenders. We explore issues such as the possible collateral consequences of community notification and registration on both offenders and their families and delve into how restorative justice may assist sexual offenders and victims. This involves a discussion of changes in future legislation.

COURSE OBJECTIVES

- (1) Understand psychological, sociological, and criminological aspects of sexual offending.
- (2) Understand the impact of high-profile cases in creating a moral panic surrounding sexual offending which has resulted in "get tough" legislation that does not reduce recidivism or increase public safety.
- (3) Elaborate the collateral consequences of sex offense legislation on those who are convicted or plea to a sex offense, as well as their family.
- (4) Understand how the application of restorative justice may bring positive change to both offenders and victims of sexual offenses.
- (5) Write clearly focused discussions/essays marked by intellectual engagement and critical reflection.
